Hair and Skin Services: Students will learn to apply and analyze shampoo, rinse and conditioning services to clients. Students will Perform hair analysis, cutting and styling services. Concepts and application of chemical waving, lightening, and coloring will be performed on clients. 4

1 Perform Shampooing and Conditioning Services. Students will describe and perform various hair services including shampooing, conditioning and procedures of the scalp. 4.1

Nail and Facial Services. Students will examine the nails and recognize common disorders and diseases. Students will apply techniques for various facial services for clients. Students will also apply face, arm, and hand massage techniques for clients. 5
