Introduction. **PSCS.B**

- 1** Career and technical education instruction provides content aligned with challenging academic standards and relevant technical knowledge and skills for students to further their education and succeed in current or emerging professions. **PSCS.B.1**
- 2** The Law, Public Safety, Corrections, and Security Career Cluster focuses on planning, managing, and providing legal services, public safety, protective services, and homeland security, including professional and technical support services. **PSCS.B.2**
- 3** Principles of Law, Public Safety, Corrections, and Security introduces students to professions in law enforcement, protective services, corrections, firefighting, and emergency management services. Students will examine the roles and responsibilities of police, courts, corrections, private security, and protective agencies of fire and emergency services. The course provides students with an overview of the skills necessary for careers in law enforcement, fire service, protective services, and corrections. **PSCS.B.3**
- 4** Students are encouraged to participate in extended learning experiences such as career and technical student organizations and other leadership or extracurricular organizations. **PSCS.B.4**

 - d analyze the essential elements and classifications of a crime; **PSCS.C.8.D**
 - e identify problems commonly associated with the enforcement of criminal laws; **PSCS.C.8.E**

 - f examine the role of emergency medical services in public safety; **PSCS.C.9.F**
 - g identify how public safety professionals manage the stress related to these jobs. **PSCS.C.9.G**

 - e identify types of sentencing and sentencing rules. **PSCS.C.10.E**

 - e identify the levels of security in prisons and jails; **PSCS.C.11.E**

12 The student identifies the roles and functions of private security systems and agencies. The student is expected to: **PSCS.C.12**

- a explain the career opportunities available in private security; **PSCS.C.12.A**
 - b discuss the history and importance of private security in the United States; **PSCS.C.12.B**
 - c examine the relationship between private security and public safety agencies. **PSCS.C.12.C**

13 The student identifies the roles and functions of fire protection services. The student is expected to: **PSCS.C.13**

- a identify the career opportunities in fire protection services; **PSCS.C.13.A**
- b explain the duties and responsibilities of firefighters; **PSCS.C.13.B**

- c recognize the importance of the operation of 911 and computer-aided dispatch systems; **PSCS.C.13.C**
 - d explain the relationships among police, fire, and emergency medical services. **PSCS.C.13.D**

14 The student identifies the roles and functions of student community organizations that support or provide additional information and guidance to those interested in law, public safety, corrections, and protective services. The student is expected to: **PSCS.C.14**

- a research and participate in community organizations such as SkillsUSA, Law Enforcement Explorer Scouts, and National Technical Honor Society; **PSCS.C.14.A**
- b identify community outreach organizations such as Citizens on Patrol; local student police organizations; or national student police organizations. **PSCS.C.14.B**
